SSYSL is pleased to announce that we are once again offering an Indoor Instructional Soccer Program this winter for players in the U5-U12 age groups. (U-5: 4yrs old by 07/31/08 to U-12: 11 yrs old by 07/31/08). This program will run 12 weeks from December through mid/late March and the season will be divided into two sessions.

The first session will be dedicated to teaching the players skills, playing fun games and they will end each practice with an instructional scrimmage game. The second session will be instructional games where the teams will play a full 45-minute game against the other teams/players in their age division.

We are very excited about offering this program once again for the young players in our league since we feel that this will give your children a fun activity to play throughout the winter. We are now entering our 9th winter season with our Indoor Soccer Facility and the Board of Directors are very proud of this facility since if you haven't seen it yet, you will be quite impressed. We have invested a lot of time and money in making this a great facility for the players of our league. Not many soccer leagues in this state or country can say that they have an Indoor Facility for their Players to learn and play the game of soccer once the weather gets cold.

The fee to have your child(ren) participate in this program is the same as our Fall Season.
One child = \$55: Two children (same family) = \$85: Three or more children (same family) = \$100.

Directions to the Indoor Soccer Facility:

From 195E, Swansea / Somerset / Seekonk / Providence:

On 195E (once you enter Massachusetts), after you cross the Braga Bridge and enter Fall River, immediately following the City Hall Tunnel take Exit #7 - Plymouth Avenue. Please note that there is one off ramp from the highway for Exits #6 & 7 and be sure to stay left on the Exit since you want #7. Proceed to the traffic light and you want to bear left onto Plymouth Avenue and go back under the highway. Just before Burger King, at the Honey Dew Donuts sign, you will take a right onto Wordell Street. Take the next left, which is Front Street and you will end up behind Burger King. On the right is a large mill (old factory) and this is the building that we are located in. Follow past the building and in between the Mill and Sherwin Williams Paint Store is the entrance to the rear parking lot. Please note that the entrance to our Facility is just around the side/rear corner of the main building – wooden steps with a tan colored awning. The Indoor Soccer Facility is on the 4th Floor.

From 195W, Rt 24 N/S / New Bedford:

On 195W, take exit #7 - Plymouth Avenue. At the end of the ramp you want to bear right onto Plymouth Avenue. Just before Burger King, at the Honey Dew Donuts sign, you will take a right onto Wordell Street. Take the next left, which is Front Street and you will end up behind Burger King. On the right is a large mill (old factory) and this is the building that we are located in. Follow past the building and in between the Mill and Sherwin Williams Paint Store is the entrance to the rear parking lot. Please note that the entrance to our Facility is just around the side/rear corner of the main building – wooden steps with a tan colored awning. The Indoor Soccer Facility is on the 4th Floor.

Note: If the gate to the rear parking lot is closed/locked, please turn around and go back to Wordell Street. Take a left onto Wordell and enter the parking lot from the side/rear entrance. Message to Parents

SPECIAL Land Purchasing Fundraiser

As many of you are already aware, SSYSL has been in the process of purchasing 17 acres of land in Swansea for the creation of our own soccer fields. This process has taken much longer than anyone ever expected and unfortunately, the cost to the league has been much higher than anyone would have expected. To date the league has spent just under \$60,000 for studies, plans, engineering development, reviews, permits, filing fees, etc. Due to this, we need to have this **SPECIAL Land Purchasing Fundraiser** in order to help pay for these unexpected expenses.

The good news is, we are in the final stages of the process and we expect to close on the land/take ownership in the coming weeks. By the time we have our first drawing, we will be land owners and the largest challenge: identifying a piece of property that is large enough, on an appropriate road, and at a cost that the league can afford, will be completed.

The league has had great success in the past with a Calendar Raffle and we hope you all can support this **SPECIAL and very important fundraising event !!!**

This Calendar Raffle is very easy for everyone, not like candy or selling some type of merchandise, here's why...

- A person has 31 chances of winning that they can win more than one prizes - if you win, your name goes back in the pool of ticket and the prize money is well worth the cost of a \$5 chance.
- Attractive prizes of \$50 for weekdays, \$100 for each weekend day and \$1,000 grand prize for the 31st of the month.

The tickets should be quite easy to sell !!!

Each player will be given a packet of 10 tickets to sell for \$5 each and we are respectfully asking that "ALL" players sell their 10 tickets. They can sell them to Mom and Dad, grandparents, neighbors, friends and parents co-workers..... so 10 tickets should be a reasonable request. SSYSL Snack Truck Serves Success

The League has completed the finishing touches on our new Snack Truck and it's serving our players and parents extremely well. We serve many great snacks and drinks at "very reasonable" prices since our goal is to offer snacks to players and families of our league to increase our revenue, but not to over charge just to make money. Parking Issues

SSYSL needs everyone's support and help in understanding the major parking issues we encounter every year. The issue is that a large number of people are parking in the marked FIRE LANES, NO PARKING AREAS and ON THE GRASS of the school. Also, no one should be parking on the south side of Whetstone Hill and people should only be parking on the North / School side of the street.

People need to park in designated parking spaces at the school and you can no longer park anywhere you like. Please note that there is a large parking area on the rear side of the school that must be used when the lot in front of the fields is full. There is plenty of parking spaces on the other side of the school and the walk is shorter than parking half way down Whetstone Hill Road. So please check it out and hopefully more people will begin to use it.

If people continue to park in non-designated areas there are serious ramifications that can occur and they include.

1) Tickets to those who park in these no parking areas and the police can decide to tow all the cars that are in violation, at the owner's expense.

2) The hiring of a Police Officer to work the school parking lots on Saturday's to enforce the parking requirements. This officer would have to be paid by SSYSL which means that everyone's registration fees for next year will need to increase in order to pay for this service.

3) The town could decide to revoke our permit to play soccer at North Elementary in which this ramification would mean that SSYSL would not have a place to have games and soccer for everyone's children could come to an end in Swansea & Somerset.

PLEASE ONLY PARK IN DESIGNATED PARKING AREAS AND DO NOT PARK IN FIRE LANES, NO PARKING AREAS AND ON THE GRASS. PLEASE FOLLOW THE SIGNS THAT HAVE BEEN POSTED.



Volunteers Needed

SSYSL is a league that has succeeded for over 25 years due to the parents who have volunteered their time to help make this league what it is today. This year we have approximately 1,000 children playing soccer in the fall season and none of this can be done without the help of parents stepping forward to volunteer their time to be coaches, board members, team Mom and Dads and referees. Soccer is a very easy sport to learn, teach and coach. We offer coaching clinics to show new coaches and parents fun games and skills that they can use with the children to teach them the game of soccer. You don't have to be an expert in soccer and it doesn't matter if you never played the game as a kid. All you need to do is be able to relate to kids and be organized. By learning some simple games, the kids will learn the skills practically on their own. You just need to guide and mentor them. If you are willing to volunteer your time to this

great game and league, please contact one of the age group directors of the league since they would love to talk to you about how you can help. Call the league at 508.673.6423 and let us know that you want to help and someone will contact you.



Soccer Goals

As most of you are aware, a few years ago SSYSL made a major investment in purchasing all soccer goals, nets and nylon sand bags to secure these goals. The league has invested a large amount of money in the purchase of this new equipment and we ask for all the players and parents to help in keeping these goals in great condition.

Please don't allow children to climb or hang on the goals and please help us in making sure that the new sand bags are placed on the rear back bar in order to secure these goals in place.

Important Topics

- ⚽ SSYSL has established a relationship with a clothing supplier who is located in Swansea, Mad Max Shirt Company. If you are interested in purchasing a polo shirt, sweatshirt, fleece, baseball cap and/or jacket with the Swansea-Somerset Youth Soccer League logo embroidered on them, please check out the samples that are located at the Snack Truck. For a small additional charge, you can have a name and jersey number added to the sleeve. At the snack truck we stock baseball caps. However, for anything else, you can take a flyer which list the articles for sale, the price and Mad Max's contact information so that you can place your order and embroidery request. Mad Max will typically have your order ready for pickup in a week.
- ⚽ Don't Address the Referee's. Coaches and parents are not supposed to be talking to the ref's or questioning calls during the games. We actually had an incident the past where a spring coach was questioning one of our younger linesman. In the end.....the 12 yr old linesman was right and the 40 yr old coach was the one who was wrong. Many coaches and parents think they know the rules, however they really don't fully understand the rules so please let the referees make the calls since they have gone to classes and taken tests on the rules. If you feel a error was made, please inform either the Referee Director (Joshua Davies) or Fred Booth. We will then determine if an error was indeed made and if so, we will explain to the referee the proper interpretation of the rules so that they can improve. Our referees are young and learning the game just like the players, so please let them learn it without the added stress from coaches or parents yelling at them.
- ⚽ Wednesday 9/24 - Please note that there will be no games scheduled on this night since it's Parent/Teachers night at North Elementary. Due to "MAJOR PARKING

ISSUES" that would occur if we had games and so that parents are free to meet with the teachers at the school, we have decided not to schedule soccer games on the same night.



- ⚽ Please be sure to check the goals before every game to ensure that the sand bags are placed on the rear of the goal. Children have been hurt in the past due to goals flipping over because a child is either hanging on the cross bar or a heavy wind flips it over. For safety purposes, please be sure to check that the bag(s) are on the rear bar and that children are not hanging or climbing on the goals.
- ⚽ Soccer cleats or sneakers, shin guards and soccer socks should be worn by every player for every game. If a child does not have the proper equipment the referee will not allow the player to play.....Soccer socks are required to be worn over the shin guards to cover any exposed plastic and the shin pads should "NOT" be on the outside of the socks. **"BASEBALL CLEATS" are "NOT" allowed** for soccer no matter if they are plastic. The reason is for safety. If you look at the bottom of a baseball cleat you will see that at the tip of the toe there is a cleat and on soccer cleats there is no cleat in this position. Children accidentally kick one another all the time and with the cleat on the tip of the toe, this can cause an injury..... Baseball cleats are not allowed no matter if the cleats are plastic or steel.
- ⚽ No Practicing at North Elementary since we schedule games for every week night until it gets dark too early to play a full game and we have games on the weekends for the entire soccer season. There is simply not enough available space to have teams going to North Elementary to practice. Also, if there are any open nights/times on the schedule – these may be used for makeup games due to inclement weather.
- ⚽ Games need to Start on Time - All coaches and players need to arrive at the fields at least 15 minutes before the game is scheduled to begin since we must start games on time...We can't have coaches and players showing up exactly when the game is supposed to begin and then have the game start 5 minutes late. Otherwise, the last game of the day is going to be 30-40 minutes late and if your the coach/parent who has the last game - you will not be happy.
- ⚽ Parents must remain in the spectator side of the field and NOT behind the net or on the player's side of the field.
- ⚽ For the younger division where the coach is on the field, only ONE COACH should be on the field coaching during the game. This is to eliminate confusion on the part of the players and due to space concerns. The second coach should be on the

bench with the players to keep them organized/focused on the game and to teach/explain things that are going on in the game to these players who are watching and hopefully learning.

- ⚽ Substitutions on the fly are not allowed. Subs are only allowed on the quarters unless a player is suddenly unable to play due to an injury, emotionally stressed or feeling ill.
